How does the EU calculate dumped imports?

Since December 2017, the EU has an alternative method to calculate dumped imports if state interference significantly distorts the economy of the exporting country. In this case, the Commission will use undistorted benchmarks to determine the 'normal value' of the product.

An anti-dumping complaint is filed with the European Commission by or on behalf of the EU producers of the product concerned either directly or via the authorities of an EU country.
